DOLB Report for 11th August

This month has been relatively quiet on the bowling front. Behind the scenes the committee has been busy.

A motion from Peter Brophy was submitted to the ladies committee to vote upon. This motion proposed to add a clause 3.1.1 citing that iOnce a player has participated in 50% of the fixtures in a particular division or team within a division in any of the MDBL pennant competitions that player cannot participate in any further matches without written approval of the MDBLÖÖÖÖÖ.

After discussion at a specially convened meeting of the ladies committee the motion was defeated unanimously.

No one spoke in favour of the motion. The Chair of Selection Jeni Stretton and selector Cheryl Brown spoke against the motion. The reasons for rejection were explored thoroughly. The MDBL relies on the Integrity Policy as outlined by Bowls WA. The league does not have to prove that the policy guidelines have not been followed. The club in question has to justify the decision.

The committee also discussed the idea of making a new qualifying period for not playing in a lower division. Everyone was of the opinion that 50% or half of the games in the season was too many Usually, half of the games are played before Christmas.
