Performance Review by the Bowls Directors against the Strategic Objectives in the Action Plan of the HHBC - Initial review conducted in August 2023.

Intro;

 The Strategic Objective of the Mens and Ladies Bowls Section is
 To Grow the Game through wider community participation and provide support for our players so that they can enjoy playing the game to their full potential.

Comment. We note that this is the third objective of our club in The Strategic Plan after Governance and Finance And Administration. We believe it should be the primary objective.

ii. In the SWOT Analysis "Appoint a Head Coach is listed as an Opportunity"

We have appointed Vicki Bowden as Head Coaching Facilitator of the Halls Head Bowling Club

iii. On 17 August both Directors Bowls met with the Coaching sub committee and sought their input on the action plan. This review represents the outcomes of that meeting together with any personal input from the individual Directors. It is the first time we have been required to provide input since the plan was endorsed and it is unfortunate that so many key players are hibernating at the moment. Hopefully we will be able to consult with the Men's and Ladies' match Committees and Selectors in the course of our next review. It is important that these people buy into the plan.

Tasks from the Plan;

3.1 Identify New Talent and provide a pathway for their development.

This is an ongoing task shared primarily by the coaches and the selectors. It was felt that both groups should work together to encourage keen talented players. At the entry level the coaches have a process to get new players ready for scroungers and social bowls. It involves teaching them the key competencies of lawn bowls, a basic understanding of the game and the etiquette involved. They are then signed off to play scroungers. The ladies have a handbook and some senior players have a mentoring role with newer bowlers who are seen to have talent. Further coaching assistance is available to all of our players who wish to improve their game. It is important that we raise the profile of our coaching volunteers via the Bias and encourage them to maintain and enhance their skills via interactions with metro league coaches and Bowls WA training opportunities.

We encourage all of our selectors to attend applicable Bowls WA selection courses to enable them to spot and help develop people with ability to reach their potential. Starting by keenly observing newcome'rs performances in social bowls as well as pennant matches.

Community Bowls has over 200 players for three months of the year and Scroungers average about 70 players every Friday. A steady stream of new members graduate from fun events to seeking coaching and then becoming bowling members. We currently have no shortage of new members. We have coaching days, external coaching days, bankers is a new initiative which has allowed several new bowlers to improve their ability at pennant level. We also run 'social bowls' at the request of outside parties. Usually a small company contact us for a team building day or a Xmas party. We get a couple of volunteers to organise them into barefoot bowls teams, charge them \$10 a head and they usually open a bar tab. Several of these social events have led to enquiries re entering teams in our Community Bowls Competition.

3.2 Undertake a review of the game format and participation

This is difficult because we have a very full calendar of social, club championship, pennants and Murray League Events. See comments below on Night Bowls. We are getting nearly 100 people every Monday for Any Gender pairs, forty or fifty on Wednesdays and Saturdays for Mens Social Bowls, More than 20 each Thursday for ladies Social Bowls and Around 70 players on Fridays for Scroungers. This is in the middle of winter!

Participation levels are excellent. There may be some scope to reintroduce night bowls for a limited season after Xmas provided we can get the volunteers to run it. Kaye has a view that some consideration be given to a short competition being run in early January for Night bowls on Sunday or Monday evenings/ afternoons. I am concerned that we do not have the volunteers to run night bowls

3.3 Develop and Review Club Coaching

Much progress has been made over the past twelve months to raising the profile of the coaches group. Much has been achieved by our hard working lady coaches with support from the Board and Bruce Walters and Jack Groves. The coaches group meets regularly and report to the board via the Director Mens Bowls. We now have a Head Coach in Vicki Bowden and I am sure she will be happy to address the board on the challenges facing the coaching Group.

In the past 12 months the coaches have;

Introduced a distinctive Club Coaches Shirt

Bought new coaching gear

Got a new shed to store their gear

Acquired new bowls donated for use of people being coached

Introduced circuit training for skills reinforcement.

Provided initial introductory coaching to all new bowling members and ensured that they have attained the minimum level of key competency prior to unleashing them to the world of scroungers.

Introduced an external coaching day for members presented by High Level external coaches..

Coordinated the access to and provision of external Bowls WA courses for players, coaches, selectors and umpires

Note; With regard to the external courses run by Bowls WA for Club Coaching Courses programmed to start on Tue 5th and Wednesday 6th at Halls Head Bowling Club the course was cancelled despite being well advertised and the fees payable by the Club. We have a problem recruiting club coaches.

I am not sure what the take up for the Preparing Teams for Selection and The Selection Module to be presented here on 27 September will be. Again the club is prepared to meet the costs of participants.

Acknowledgement;

Over the past year the coaches group have put in an extraordinary effort we need to continue to encourage and support the coaching group for the benefit of the club as a whole.

Thanks to Jacki Henry, Vicki Bowden, Sue Edwards, Cheryl Brown, Jack Groves, Gary Bennet and Bruce Walter for their efforts.

3.4 Develop a Junior Bowls Program

Developing a Junior Bowls Program has been a difficult process and has suffered a few setbacks. Vicki is working with others to get this back on track. There is a proposal for a joint initiative with Mandurah Bowling Club. It is an area in which progress is slow and in which none of our current coaching group are keen to be heavily involved in given other priorities.

3.5 Host State and National Championships

This was considered to be very ambitious given our parking problems. If we were to be successful we would need a mentor at Bowls WA level to get us in the door and shuttle buses to and from a parking area.

3.6 Investigate playing more night bowls – pennants and championships

See earlier comments at 3.2 regarding social night bowls. With regard to pennants and championships the issue needs to be discussed by the ladies' and men's bowls committees. Given the amount of whingeing last year by several players and board members who do not wish to play at night because it is too dark. I think the board may have to step in and make a direction to the match committees to schedule more derbies and club championships to be played at night.
